This panel measures Calcium, Phosphorus and Vitamin D which are vital for bone metabolism and maintaining its health. These markers are integral to bone formation, resorption, and mineralization, and their levels can indicate the presence of bone disorders such as osteoporosis. Osteoporosis is a condition characterized by decreased bone strength leading to increased risk of fractures. It is prevalent in postmenopausal women, but may also occur in men and women with underlying conditions or risk factors associated with bone demineralization. By identifying changes in these markers, this test can help diagnose osteoporosis early, allowing for prompt intervention and management.
